Auditor's Report

To Kunming Yundi Behavior and Health Research Centre,

I. The auditor's report on the financial statements

We have audited the accompanying financial statements of Kunming Yundi Behavior and Health Research Centre, which comprise the balance sheet as at December 31, 2016, and the operating sheet and cash flow statement for the year then ended.

(I). Management's responsibility for the financial statements

Management of Kunming Yundi Behavior and Health Research Centre is responsible for the preparation and fair presentation of these financial statements. This responsibility includes: (a) preparing and fairly presenting these financial statements in accordance with Accounting System for Nongovernmental Nonprofit Organizations; (b) designing, implementing and maintaining internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error; selecting and applying appropriate accounting policies.

(II). Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with China Standards on Auditing. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance to whether the financial statements are free from material misstatement.

An audit involves performing audit procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, We considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

(III). Opinion

In our opinion, the financial statements give a true and fair view of the financial position of Kunming

Yundi Behavior and Health Research Centre as of December 31, 2016, and of its financial performance for the 2016 then ended in accordance with the Nongovernmental Nonprofit Organization Accounting System.

II. Auditing emphases required to be disclosed on nongovernmental nonprofit organization for annual inspection

According to “III. Annual inspection (IIIV) Financial Auditing: 4. The audit engagement shall state the above auditing emphases. The social organization shall require the accounting firm which undertakes its financial auditing to issue a statement of auditing results and to detail all terms related to the audited unit as required by Yunnan Provincial Civil Affairs Bureau” stated in the Notice on Conducting Annual Inspection of Non-Governmental Nonprofit Units in 2014 (Y.M.M. (2014) No.1) publicized by Yunnan Provincial Civil Affairs Bureau on January 14, 2014, the auditing emphases are disclosed as follows:

(I) Financial management

1. Execution of Nongovernmental Nonprofit Organization Accounting System

Kunming Yundi Behavior and Health Research Centre has executed the Nongovernmental Nonprofit Organization Accounting System and set up related accounts as needed.

2. Establishment of basic account

Kunming Yundi Behavior and Health Research Centre has opened an account in FUDIAN BANK CO., LTD. Lianfa Branch (Account No. 9160120109111327).

3. Revenue and expenditure

The annual revenue in 2016 is RMB 87,131.71 yuan, including donations of RMB 86,391.00 yuan and other revenue of RMB 740.71 yuan. The annual expenditure in 2016 is RMB 621,756.13 yuan, including activity cost of RMB 621,756.13 yuan.

4. Establishment and performance of financial system

Kunming Yundi Behavior and Health Research Centre has set up systems for cashier, accounting books and file management.

5. Net asset

Kunming Yundi Behavior and Health Research Centre has net assets of RMB 25,221.55 yuan for the 2016 then ended, including unlimited assets of RMB 4,471.55 yuan and limited assets of RMB 20,750.00 yuan.

(II) Increase in employment and social insurance joined by employees signed labor contracts

There is 0 staff which signed labor contract with Kunming Yundi Behavior and Health Research Centre as of December 31, 2016.

(III) Collection of membership fees from social organizations

Kunming Yundi Behavior and Health Research Centre has no membership fees as of December 31, 2016.

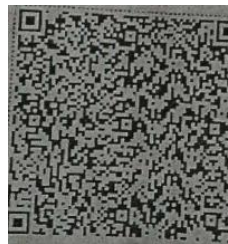

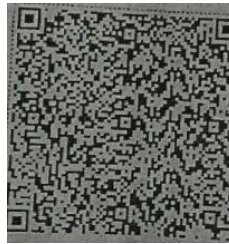
